COPYRIGHT TRIBUNAL RULES

We refer to Winnie Ng's letter of 31 August 2009 inviting comments on the Department's Consultation Paper on the proposed Copyright Tribunal Rules. The APAA Copyright Committee has reviewed the Consultation Paper and agrees with the majority of the proposals for drafting the new rules.

With regard to the proposal at 4(b) of the paper that there be one standard procedure and form for all applications, given the different nature of issues to be determined by the Tribunal, we consider it will be difficult to draft one form that will minimise the complexity of applications.

The Copyright Tribunal hears applications relating to:

1. Licensing schemes
2. Licensing by Licensing Bodies
3. Determining awards for employees for use of his/her work outside reasonable contemplation
4. Obtaining the Tribunal's consent on behalf of owners of rights of reproduction of a performance whose identity cannot be ascertained.


While it is likely the facts and legal issues to be determined in 1 and 2 will be similar, in relation to 3 and 4, they are likely to be substantially different.

Using one standard form may in fact increase rather than decrease complexity. In particular, as the applicant under 3 is likely to be an employee, if the goal is to assist unrepresented parties one form specific to this type of application may be preferable.

We recommend that the rules do not specify forms to be used, but leave it to the discretion to the Tribunal to make provision for appropriate forms to be used based on their experience of handling cases.

We do not see a major issue with one standard procedure being adopted.
