I hereby direct as follows:

Electronic filing

(a) Subject to paragraph (d), for the purpose of the sending of an electronic record by electronic means to an information system designated by the Registrar of Trade Marks, Patents or Designs in accordance with rule 109(2) of the Trade Marks Rules, section 93A(2) of the Patents (General) Rules or section 60A(2) of the Registered Designs Rules, the hours of business and business days of the Trade Marks Registry, Patents Registry and Designs Registry shall be as follows:

Monday to Sunday 24 hours¹

Earliest filing by fax under section 15 or 23 of the Patents Ordinance

- (b) Subject to paragraph (d), for the purpose of receiving by fax the earliest filing of:
 - (i) any part of any request to record a designated patent application under section 15 of the Patents Ordinance; and
 - (ii) any part of any request for registration and grant under section 23 of the Patents Ordinance,

the following shall be the hours of business and business days of the Patents Registry:

Monday to Friday 24 hours

Others

(c) Subject to paragraph (d), the hours of business and business days of the Trade Marks Registry, Patents Registry and Designs Registry for the purpose of the transaction by the public of all classes of business under the Ordinances and the Rules, other than any business referred to in paragraph (a) or (b) above, shall be as follows:

Monday to Friday 9:00 a.m. to 5:45 p.m.

For all classes of business

- (d) For computation of time in respect of any business before the Trade Marks, Designs and Patents Registries under the Ordinances and the Rules (including all classes of business covered by paragraphs (a), (b) and (c) above):
 - (i) if the last day of a period is a Saturday, a public holiday, a gale warning day, a black rainstorm warning day or an extreme conditions day, the period shall include the next following day, not being a Saturday, a public holiday, a gale warning day, a black rainstorm warning day or an extreme conditions day; and
 - (ii) where any act or proceeding is directed or allowed to be done or taken on a certain day, then if that day is a Saturday, a public holiday, a gale warning day, a black rainstorm warning day or an extreme conditions day, the act or

proceeding shall be considered as done or taken in due time if it is done or

taken on the next following day, not being a Saturday, a public holiday, a

gale warning day, a black rainstorm warning day or an extreme conditions

day.

"black rainstorm warning day" (黑色暴雨警告日) means any day throughout or

for part of which a black rainstorm warning is in force; and

"gale warning day" (烈風警告日) means any day throughout or for part of which

a gale warning is in force.

"extreme conditions day" (極端情況日) means any day on which extreme

conditions arising from a super typhoon or other natural disaster of a substantial

scale exist by reference to an announcement made by the Chief Secretary for

Administration.

This Notice, with effect from 16 February 2024, supersedes all previous Notices of

Business Hours and Business Days of the Trade Marks Registry, Patents Registry and

Designs Registry.
