Class 1:

Chemicals for use in industry, and namely product of used degreasing during operations of fabrication, compositions for repairing inner tubes of tires [tyres], size in the repair of air chambers, mastic for tires, compositions for repairing tyres, tyre repairing compositions; release agent preparation (maintenance product); brake fluid.

Class 12:

Vehicles, apparatus locomotion by land, by air, or by water; engines and motors for land vehicles; cycles; inner tubes for pneumatic tyres, repair outfits for inner tubes, adhesive rubber patches for repairing inner tubes; tyres, non-skid devices for vehicle tires; anti dazzle and anti glare devices for vehicles; anti-theft devices for vehicles; head-rests for vehicle seats; covers for cars of children; luggage carriers for vehicles; safety seats for children for vehicles; body covers for vehicles and saddle cloths; seat covers for vehicles; ski carriers for cars; cycle hubs; gearings for land vehicles and horns; cycle stands, cycles; cycles; cycle frames; bottle gourd holders, all these aforesaid goods are for bicycles; brakes, handlebars, direction indicators, pedals, pumps, spokes, saddles; mud guards, tubeless tires for bicycles; forks for bicycles; snubbers; carriers for bicycles.

Class 14:

Chronometric instruments; watches, boxes adapted for watches, straps for wrist watches, chronometers.

Class 18:

Bags, travel bags, sport bags; sacks garment covers (for the travel); sport bags and sacks of travel intended for cycling; satchels of frames, satchels of handlebar, satchels of saddles, satchels for bicycles.

Class 25:

Garments for men, women and children namely jerseys, underwear, robes, bath robes, swim wear, bathing caps; bath slippers and sandals; pajamas, dressing gowns, sweaters, skirts, dresses, trousers, jackets, topcoats, anoraks (not raincoats), shirts, t-shirts, layettes, neckties, scarves, belts; gloves (clothing), waterproof clothing namely topcoats, raincoats, anoraks; snow suits, wet suits for water skiing, hats, caps, socks, stockings, tights, gaiters for the ski; footwear (except orthopaedic footwear), slippers, boots; sport shoes, beach shoes, skiing boots, after-ski boots, booties of escalation, soles; clothes in the sports (except in the diving) namely pants, jackets, shorts, t-shirts, jumpers; headbands (clothing).

Class 28:

Games; toys; playing balls; gymnastic and sporting articles (except clothing, footwear and mats); Stationary bicycles; Exercise bicycles; Machines and appliances for gymnastics; Bicycles (fixed) at frequency of cyclists raised.

ERRATA

In relation to the Hong Kong Intellectual Property Journal published on 12 July, 2013:

Under the section “Acceptance for Registration (Full Version)”, Class 1-5 (pages 3-5), Class 11-15 (pages 19 and 25), Class 16-20 (page 45), Class 21-25 (page 34), Class 26-30 (page 7), the specification of goods in Classes 1, 12, 14, 18, 25 and 28 of Trade Mark Application No. 302323926 should read as follows:

Class 1:

Chemicals for use in industry, and namely product of used degreasing during operations of fabrication, compositions for repairing inner tubes of tires [tyres], size in the repair of air chambers, mastic for tires, compositions for repairing tyres, tyre repairing compositions; release agent preparation (maintenance product); brake fluid.

Class 12:

Vehicles, apparatus locomotion by land, by air, or by water; engines and motors for land vehicles; cycles; inner tubes for pneumatic tyres, repair outfits for inner tubes, adhesive rubber patches for repairing inner tubes; tyres, non-skid devices for vehicle tires; anti dazzle and anti glare devices for vehicles; anti-theft devices for vehicles; head-rests for vehicle seats; covers for cars of children; luggage carriers for vehicles; safety seats for children for vehicles; body covers for vehicles and saddle cloths; seat covers for vehicles; ski carriers for cars; cycle hubs; gearings for land vehicles and horns; cycle stands, cycles; cycles; cycle frames; bottle gourd holders, all these aforesaid goods are for bicycles; brakes, handlebars, direction indicators, pedals, pumps, spokes, saddles; mud guards, tubeless tires for bicycles; forks for bicycles; snubbers; carriers for bicycles.

Class 14:

Chronometric instruments; watches, boxes adapted for watches, straps for wrist watches, chronometers.

Class 18:

Bags, travel bags, sport bags; sacks garment covers (for the travel); sport bags and sacks of travel intended for cycling; satchels of frames, satchels of handlebar, satchels of saddles, satchels for bicycles.

Class 25:

Garments for men, women and children namely jerseys, underwear, robes, bath robes, swim wear, bathing caps; bath slippers and sandals; pajamas, dressing gowns, sweaters, skirts, dresses, trousers, jackets, topcoats, anoraks (not raincoats), shirts, t-shirts, layettes, neckties, scarves, belts; gloves (clothing), waterproof clothing namely topcoats, raincoats, anoraks; snow suits, wet suits for water skiing, hats, caps, socks, stockings, tights, gaiters for the ski; footwear (except orthopaedic footwear), slippers,

boots; sport shoes, beach shoes, skiing boots, after-ski boots, booties of escalation, soles; clothes in the sports (except in the diving) namely pants, jackets, shorts, t-shirts, jumpers; headbands (clothing).

Class 28:

Games; toys; playing balls; gymnastic and sporting articles (except clothing, footwear and mats); Stationary bicycles; Exercise bicycles; Machines and appliances for gymnastics; Bicycles (fixed) at frequency of cyclists raised.
