The opponent shall, at the same time as he files the notice of opposition, send a copy of it to the applicant of the application in question.

warehousing services; warehousing, transportation, storage, packaging and packing, and delivery services of consumer, goods, food and household products; transportation of goods, people, parcels, mail matters, small packets; transport of valuables; transportation services by rail, road, sea and air; transporting goods from one place to another by land and air consisting of the pick-up, transportation, delivery, tracking and storage of documents, packages and cargo; computerized collection, storage and delivery of goods; door-to-door collection of goods and documents; preparation and completion of documents relating to packaging and freight shipping transactions using a global information network; clearance of exported and imported documents, packages and freight through domestic and international customs; forwarding agency-services; arranging of transportation, packaging, crating, inspection of goods for transportation and delivery of goods; planning, supervision and co-ordination of transportation and forwarding of goods; transport brokerage information services relating to transportation and forwarding services provided on-line from a computer database on an international computer network; removal services; rental of warehouses, containers, trucks, vehicles, ships, cruises and aeroplanes; transport reservation, parking place rental; delivery of messages and of fresh, dried and artificial flowers and flower arrangements, potted plants, fruits, food hampers, wines and spirits, baby items, balloons and other gift items; delivery of goods and parcels by messenger; wrapping and packaging of such aforesaid items in wicker and rattan baskets, boxes, glass vases, ceramic vases, other containers and packaging materials; wrapping and packaging services; electronic tracking the goods and items and systematic cross-linking of the flow of the goods, all being part of the transport services provided; consignments of written communications and other written messages, letters, postcards, printed matter, goods, circulars, addressed and unaddressed advertising materials, books, newspapers, magazines, printed papers; consignments for blind people; consignments of written communications and messages; provision of information, consultancy and advisory services for the aforesaid services.
