(For example, if the publication date is 4 April 2003, the last day of the 3-month period is 4 July 2003.) The notice of objection shall include a statement of the grounds of objection, which statement shall, in particular, explain how the objector would be affected by the amendment and why in the objector's opinion the amendment would be contrary to section 46 of the Trade Marks Ordinance. The objector shall, at the same time as he files the notice of objection, send a copy of it to the applicant of the application in question.

It should be noted that under rule 95 of the Trade Marks Rules, extension of time cannot be allowed for filing the notice of objection.
