Online or downloadable electronic publications in the nature of books, magazines, periodicals, multimedia presentation, newspapers, journals in the field of computer, romance, juvenile, mystery, detective, literary, fantasy, science fiction, thrillers, historical, erotica, classics, short stories, action, adventure, poetry, business, finance, economics, education, biography, autobiography, history, social science, medical, psychology, self-help, political science, health and fitness, family and relationships, science, advice and how to, arts, entertainment, comics and graphics novels, children's books, cooking, food and drink, humour, lifestyle and home, reference, sports, travel and general interests; desktop publishing software; software for processing images, graphics and text; portable and handheld digital electronic devices for recording, organizing, transmitting, manipulating, and reviewing text, data, image, and audio files; wireless communication device featuring voice, data and image transmission including voice, text and picture messaging, video and still image camera, functional to purchase music, games, video and software applications over the air for downloading to the device; computer software for administration of computer networks; electronic display interfaces; computer software and applications for use with electronic book readers, computers, tablet computers, mobile hand-held computer apparatus, smartphones and portable hand-held apparatus for reading, displaying, receiving, purchasing, organizing, sharing, lending, accessing, storing, downloading, synchronizing, streaming, transmitting over wired, wireless and wi-fi, sampling, loaning electronic and digital publications and digital media; computer hardware and computer software programmes for the integration of text, audio, graphics, still images and moving pictures into an interactive delivery for multimedia applications; all included in Class 9.

Telecommunication services, namely, transmission of voice, data, graphics, images, audio and video by means of telecommunication networks, wireless communication networks, and the internet; communication services, namely, transmission of voice, audio, visual images and data by telecommunication networks, wireless communication networks, the internet, information services networks and data networks; providing online communications links which transfer the web site user to other local and global web pages; telecommunication services, namely, providing online facilities for real time interaction with other computer users concerning topics of general interest; providing online forum for transmission of messages among computer users; providing virtual chat rooms established via text messaging; all included in Class 38.

類別 Class 41

Education services, namely, providing live and online classes in the field of general interest; entertainment information; entertainment services, namely, multimedia production services; book publishing; electronic desktop publishing; provision of information relating to publishing of electronic publications; publishing services, in particular publishing of books, magazines, periodicals and media content in digital format; all included in Class 41.

類別 Class 42

Hosting of digital content on the internet; provision of internet search engines; providing a website featuring a search engine for media content; design and development of computer software; installation, maintenance and repair of computer software; computer programming; document data conversion from one computer format to another; application service provider, namely, hosting computer software applications of others; all included in Class 42.
