The Registrar of Trade Marks has received the following requests for amendment of app1ications under section 46 of the Trade Marks Ordinance（Cap．559）．

Under rule 26 of the Trade Marks Rules（Cap． 559 sub．1eg．），any person claiming to be affected by the proposed amendment may，within 3 months after the date of this publication，file a notice of objection on Form T6．（For example，if the publication date is 4 April 2003，the 1ast day of the 3 －month period is 4 Ju1y 2003．）The notice of objection shall include a statement of the grounds of objection，which statement sha11，in particu1ar，exp1ain how the objector wou1d be affected by the amendment and why in the objector＇s opinion the amendment would be contrary to section 46 of the Trade Marks Ordinance．The objector sha11，at the same time as he files the notice of objection，send a copy of it to the app1icant of the app1ication in question．

It should be noted that under rule 95 of the Trade Marks Rules，extension of time cannot be allowed for filing the notice of objection．
