## ACCEPTANCE FOR REGISTRATION

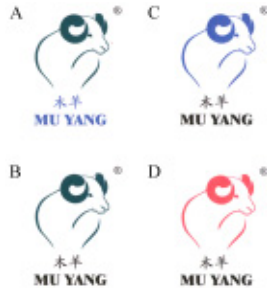


