Non-electric cables and wires of common metal; ironmongery, small items of metal hardware; pipes and tubes of metal; safes; goods of common metal not included in other classes.

Hand tools and implements (hand-operated); cutlery; side arms; razors.

類別 Class 9

Photographic, cinematographic, optical apparatus and instruments; apparatus and instruments for conducting, switching, transforming, accumulating, regulating or controlling electricity; apparatus for recording, transmission or reproduction of sound or images; magnetic data carriers, recording discs; calculating machines, data processing equipment and computers; sunglasses, spectacle glasses; spectacles (optics); spectacle cases; spectacle frames, electrical communication apparatus and instruments for cell phones.

Precious metals and their alloys and goods in precious metals or coated therewith, not included in other classes; jewellery, precious stones; horological and chronometric instruments; jewellery cases (caskets).

Paper, cardboard and goods made from these materials, not included in other classes; printed matter; bookbinding material; photographs; stationery; adhesives for stationery or household purposes; artists' materials; paint brushes; typewriters and office requisites (except furniture); instructional and teaching material (except apparatus); plastic materials for packaging (not included in other classes); printers' type; printing blocks; money clips.

Household or kitchen utensils and container; combs; sponges; brushes (except paint brushes); brush-making materials; articles for cleaning purposes; steelwool; unworked or semi-worked glass (except glass used in building); glassware, porcelain and earthenware not included in other classes; combs for the hair.

Ropes, string, nets, tents, awnings, tarpaulins, sails, sacks and bags (not included in other classes); padding and stuffing materials (except of rubber or plastics); raw fibrous textile materials.

Yarns and threads, for textile use.

類別 Class 26

Lace and embroidery, ribbons and braid; buttons, hooks and eyes, pins and needles; artificial flowers; barrettes (hair-slides); bows for the hair; false hair; hair bands; hair curling pins; hair grips (slides); hair nets; hair ornaments; hair pins; plaited hair; toupees; tresses of hair; hair ribbons; hair pieces; ornamental combs.

Gymnastic and sporting articles not included in other classes; decorations for Christmas trees.

類別 Class 29

Meat, fish, poultry and game; meat extracts; preserved, frozen, dried and cooked fruits and vegetables; jellies, jams, compotes; eggs, milk and milk products; edible oils and fats.
