Under rule 102(3) of the Trade Marks Rules (Cap. 559 sub. leg.), any person claiming to be affected by the amendment may, within 3 months after the date of this publication, file a notice of opposition on Form T6. (For example, if the publication date is 4 April 2003, the last day of the 3-month period is 4 July 2003.) The notice of opposition shall include a statement of the grounds of opposition, which statement shall, in particular, explain how the opponent would be affected by the amendment and why in the opponent's opinion the amendment would be contrary to section 6(1) or (2) of Schedule 3 of the Trade Marks Ordinance. The opponent shall, at the same time as he files the notice of opposition, send a copy of it to the owner of the registered collective trade mark in question.

It should be noted that under rule 95 of the Trade Marks Rules, extension of time cannot be allowed for filing the notice of opposition.
