### ACCEPTANCE FOR REGISTRATION (FULL VERSION)

The Registrar of Trade Marks has accepted the following trade marks for registration under section 42 of the Trade Marks Ordinance (Cap. 559). Under section 43 of the Trade Marks Ordinance and rule 15 of the Trade Marks Rules (Cap. 559 sub. leg.), the particulars of the applications are published.

Class 4:

fuel, solid fuel, coke, gaseous fuel, liquefied petroleum gas, gaseous fuels in bombe for portable cooking stove, wax, sumac wax, beeswax, candles.

Class 5:

Class 14:

tableware of precious metal, drinking cups of precious metal, dishes and plates of precious metal, soup bowls of precious metal, teapots of precious metal, pepper pots of precious metal, sugar bowls of precious metal, clocks and watches, ashtrays of precious metal, key rings, tie pins, necklaces, rings.

Class 16:

vinyl shopping bags, printed matters, cards, calendars, magazines, comic magazines, information magazines, hobby and practical magazines, books, newspapers, maps, stationery, ball point pens, pencils, mechanical pencils, felt writing pens, felt marking pens, writing brush pens, writing brushes, pocket notebooks, notebooks, writing pads, envelopes, calligraphy paper, thumbtacks, paper-clips, rubber erasers, Indian inks, rulers, adhesive tapes, correcting fluid, correcting tapes, index label, album, toilet paper, tissue paper, pocket tissue paper, wet tissue paper (hygienic paper), babies' diapers of paper, adults diapers of paper, food wrapping plastic film for household use, garbage bags of plastics, special envelopes for presenting a gift of money on occasions mournful and joyous, coloring books.

Class 20:

drinking straws, hand-held flat fans, hand-held folding fans, hand mirrors, clothes drying hangers.

Class 21:

gloves for household purposes, cooking pots and pan [non-electric], kettles [non-electric], tableware not of precious metal, Japanese style tea-serving pots, drinking cups, dishes and plates, Japanese rice bowls, lunch-boxes, teacups, Japanese style soup serving bowls, paper cups (disposable), paper plates (disposable), cups of plastics (disposable), half-split chopsticks (disposable), pepper pots, sugar bowls, and salt shakers not of precious metal, Japanese style cooked rice scoops, bottle openers, corkscrew wine opener, chopping boards for kitchen use, toothpicks, tin foil for kitchen use, clothes pegs, wash basins, scrubbing brushes, dust-pans, bathroom pails, chewing goods for pet dogs, sheet or mat for domestic pet's (cat and dog) excreta (care sheet for domestic pets), clothes brushes, flower vases and bowls not of precious metal, combs, soap holders and boxes, toilet cases, nail brushes, powder puffs, toothbrushes [non-electric], hair brushes, electric toothbrushes, handy shoe shiners, sticky sheet for catching cockroaches.

Class 23:

threads and yarns for textile use, sewing thread and yarn.

Class 24:

towels, handkerchiefs; covers of futon and quilts (bedding), pillowcases, dish cloths.

Class 25:

uniforms, liveries, jackets, skirts, trousers, overcoats, topcoats, sweaters, sport shirts, shirts for suits, blouses; men's underwear, undershirts, underpants; women's underwear, panties, undershirts, slips; socks and stockings, panty hose, support panty hose; slippers, sandals, raincoat, babies diapers of textile.

Class 26:

needles, ribbons, hair nets, hair pins and grips, buttons and hooks [haberdashery], hair curlers [non-electric], shoe laces.

Class 28:

toys, namely, metal toys, namely, toy whistles, wood or bamboo toys, paper toys, namely, assorted pieces of folding paper, paper balloons; plush toys, namely, stuffed toys; plastic toys, namely, minicar, one-piece toys formed of celluloid, clockwork toys of plastics, hollow celluloid toys, plastic toys formed by blow molding; rubber toys, namely, rubber balls, rubber balloon; musical toys, namely, toy harmonicas; toy sets, namely, toy construction sets, housekeeping play sets; toy pistols, toy masks, toy fireworks, toy Christmas trees, Toy Koi-nobori streamers (carp streamers), kites, clay

[play articles], glass beads [play articles], dolls, namely, dolls sitting posture, doll figures for decorating personal space; dice, playing cards, mini-chess game, mini-othello game, baseball and softball implements, namely, rubber baseballs, insect collecting tools (toys), namely, insect nets [butterfly nets], insect collecting basket, soap babbles (toys), pet toys.

Class 29:

edible oils and fats, namely, vegetable oils and fats food, namely, corn oil, sesame oil, soy bean oil; processed oils and fats, namely, margarine; milk products, namely, milk, milk beverage, yogurt, yogurt beverage, cream [milk product], cheese, lactic acid drinks, lactic acid bacteria drinks, butter, powdered milk [not for babies], condensed milk; meat for human consumption, namely, beef, chicken [meat], pork; eggs, namely, quail eggs, hen eggs; edible aquatic animals [not live], processed meat products, namely, beef jerky, pork jerky, croquettes, sausages, canned cooked meat, ham, bacon; processed marine products, processed fish, shellfish and seaweed products, blocks of boiled, smoked and then dries bonitos, flakes of dried fish meat, sheets of dried laver, toasted sheets of laver, food boiled down in soy, fish paste products, namely, tube-shaped toasted cakes of fish paste (Chikuwa), steamed cakes of smashed fish and yam, steamed or toasted cakes of fish paste (Kamaboko), fish sausages, processed vegetables and fruits, namely, canned or bottles fruits, dried fruits, dried and seasoned plums; jams, peanut butter, marmalade, fermented bamboo shoots boiled and preserved in salt, canned or bottled vegetables, pickled vegetables; salted plums, fried tofu (soybean curd) pieces, freeze-dried tofu pieces, potato jelly (Konnyaku), soybean milk, tofu (soybean curd), curry, stew and soup mixes, namely, instant or pre-cooked curry, instant or precooked stew, instant or pre-cooked soup, instant or pre-cooked miso (fermented soybean paste) soup; cupped instant or pre-cooked curry, cupped instant or precooked stew, cupped instant or pre-cooked soup, cupped instant or pre-cooked miso (fermented soybean paste) soup; dried flakes of laver for sprinkling on rice in hot water, flavored granular products being made of egg, salmon meat and laver for sprinkling on rice (Furikake), roasted and seasoned edible seeds, raw pulses, namely, red beans, soybeans, peanuts; protein for human consumption, vegetable salads, fruit salads, kumiss [milk beverage], roasted beans, sugar beans, potato chips, sashimi (slices of raw fish dish).

Class 31:

edible aquatic animals [live], edible seaweed, vegetables, fruits [fresh or chilled], foxtail millet [unprocessed], sesame [unprocessed], buckwheat [unprocessed], corn [unprocessed grain], sorghum [unprocessed], seeds and bulbs, natural flowers, pet food for dogs, pet food for cats.

Class 32:

beer, brewed malt-based alcoholic beverage in the nature of a beer, carbonated drinks, namely, non-alcoholic beer, isotonic beverages, mineral water, cola drinks, soda pops, ginger ale, aerated water, ramune (Japanese soda pops), lemonades, lemon squash, non-alcoholic fruit juice beverages, namely, orange juice beverages, grape juice beverages, tomato juice beverages, tomato juice beverages, pineapple juice beverages, apple juice beverages; whey beverages, vegetable juices.

Class 33:

Japanese liquors, namely, distilled spirits of rice, Japanese white liquor, sake (Japanese liquors); alcoholic beverages of fruit, namely, grape wine, cider; Chinese liquors, namely, Chinese brewed liquor [Laojiou], Chinese white liquor [Baiganr], tonic liquor flavored with Japanese plum extracts.

Class 34:

tobacco, namely, cigarettes; smoker's articles not of precious metal, namely, ashtrays, pocket ashtrays, cigarette filters, lighters for smokers, liquid gas bombe for cigarette lighters; matches, namely, safety matches, sulfur matches.

Class 35:

advertising and publicity, issuance of trading stamps, business management analysis or business consultancy, marketing research, providing information on commodity sales, import-export agencies, arranging newspaper subscriptions, document reproduction, marketing studies, efficiency experts, sales promotion for others, procurement service for others (in respect of post stamps, post cards, and revenue stamps), business mediation and agencies for arranging contract of sale of goods by catalogue, business information agencies for selling goods and mediation for contract of sale of goods, the bringing together, for the benefit of others, of a variety of goods, enabling customers to conveniently view and purchases those goods in a supermarket or a convenience store.

Class 36:

payment collection agencies for collecting public utility charges for gas, electric power or waters, payment collection agencies for collecting tax, or insurance of state and local governments, payment collection agencies for collecting communication charges for mail-order sale payments, issuance of credit card services (credit card services), debit card services, electronic funds transfer, charitable funds raising, issue of token value, loans [financing], agencies for non-life insurance, agencies for finalizing property insurance contract, rent a space or rooms for a mailbox and an ATM for postal savings inside a store, depositing and withdrawing of postal savings agencies through ATM, agencies for collecting payments of sale goods, agencies for collecting payments for selling goods-preservation services of the money collected from the consumer.

Class 37:

laundrying.

Class 38:

facsimile transmission, communication by computer terminals, computer aided transmission of message and images, broadcasting by satellite communications.

Class 39:


car transport, namely, transport agency services for arranging transportation of cargo, transport agency services relating to contracts on transportation of goods by road, rail and air, checkroom for postal parcels, agencies for undertaking postal service of express and registered mails, agencies for delivery services of postal packages.

Class 40:

photographic enlarging, photographic printing, photographic film development, offset printing.

Class 43:

providing food and beverages for consuming in convenience stores, providing tea, coffee, cocoa, carbonated drinks or fruit juices beverages, providing cooked Oden in convenience stores, accommodation bureaus (brokering reservations for hotels,

Class 3:

Chemicals and chemical compositions for use in cleaning steel, aluminum, galvanized and mixed metal surfaces for general industrial use in the manufacture of metal products; chemicals and chemical compositions for use in industry, namely cleaning agents to remove contaminants from industrial process systems and paint strippers to remove paint from equipment surfaces in paint spray booth operations.

Class 5:

Pharmaceutical and veterinary preparations, medicines and substances; diagnostic agents, preparations and substances for medical purposes; contrast media for medical imaging; diagnostic scanning agents for in vivo use; diagnostic imaging agents for magnetic resonance imaging (MRI); radiopharmaceutical products; radioactive substances for use in nuclear medicine; radioactive pharmaceutical preparations and non-radioactive reagents for producing radiopharmaceuticals for in vivo diagnostic or therapeutic use; gases and gas mixtures for medical imaging; chemical compositions used to inhibit cooling water system fouling due to mollusca and microorganism; bacteriacides, fungicides, and algacides for use in the treatment of aqueous systems used in the preparation of wood pulp, paper, and paper products; compositions for the control of bacteria, fungi, and algae.

Class 6:

Metal locks; metal security enclosures, namely, key cabinets, storage tubes and

storage boxes for securing keys; metal lockboxes for residential, vehicular, industrial and real estate sales use; metal key cabinets for locking, tracking and storing keys; metal key safes.

**Class 7:**

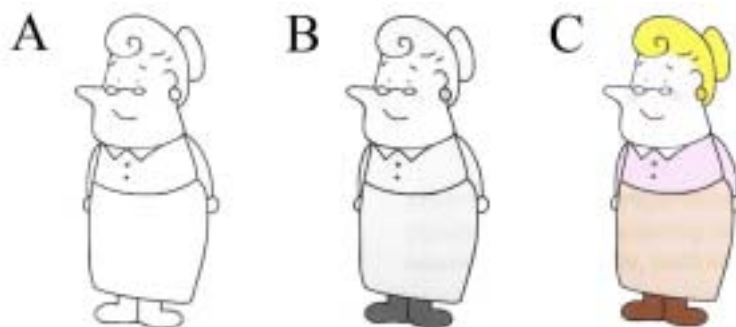
