ACCEPTANCE FOR REGISTRATION



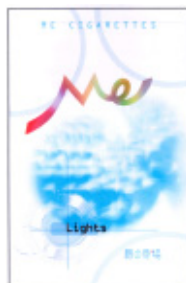

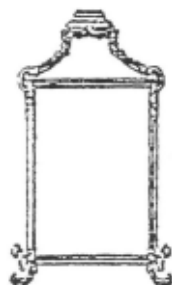
