類別 Class 2

Paints; varnishes; lacquers; inks; coatings; preservatives against rust and against deterioration of wood; colorants; mordants; raw natural resins; metals in foil and powder form for painters, decorators, printers and artists.

類別 Class 3

Bleaching preparations and substances; preparations and substances for laundry use; cleaning, polishing, scouring and abrasive preparations and substances; soaps; perfumery; essential oils; cosmetics; deodorants for personal use; hair lotions; dentifrices.

類別 Class 4

Wetting and binding compositions; fuels; paraffins; electricity.

類別 Class 5

Pharmaceutical and veterinary preparations and substances; chemicals and chemical additives, preparations and substances used in medicines; sanitary preparations for medical purposes; dietetic substances adapted for medical use; plasters; materials for dressings; disinfectants; preparations and substances for destroying vermin; fungicides; herbicides; insecticides; but not including pharmaceutical goods for remedying Vitamin D and calcium deficiency and for osteoporosis treatment.

類別 Class 17

Rubber, gutta-percha, gum, asbestos, mica and goods made from these materials; films; packing, stopping and insulating materials; plastics and synthetic resins in semi-processed form; plastics in extruded form for use in manufacture or packing; plastic in sheet, rod, film or tube form; plastics in fibre form (not for textile use); compounds of plastics (semi-processed); compounds of synthetic resins (semi-processed), components and assemblies of synthetic resins in moulded form for use in manufacture.

類別 Class 35

Organisation and management of customer loyalty schemes; advertising the goods and services of others; rental of advertising space; collecting, processing and supplying (preparing) data; professional consultations relating to franchising.

類別 Class 37

Drilling services.

類別 Class 42

Scientific and technological services and research and design relating thereto; industrial design, analysis and research services; design and development of computer hardware and software; engineering services; surveying services; exploration services; geological surveys; geological services; environmental research and advice services; preparation of engineering drawings, technical documentation and reports; analytical services; commissioning and inspection of plant, machinery and apparatus; but not including scientific research services for remedying Vitamin D and calcium deficiency and for osteoporosis treatment.
