根據《商標規則》(第 559 章附屬法例)第 49(3)及 16 條，任何人擬就有關申請提出反對，須在本公告公布的日期起計三個月內，採用表格第 T6 號提交反對通知。(例如，若果公布日期為 2003 年 4 月 4 日，則該三個月的最後一日為 2003 年 7 月 3 日。)反對通知須載有反對理由的陳述。反對人須在提交反對通知的同時，將該通知的副本送交有關註冊商標擁有人。

### APPLICATION FOR RECTIFICATION OF ERROR OR OMISSION IN THE REGISTER BY OWNER

The Registrar of Trade Marks has received an application filed under section 57 of the Trade Marks Ordinance (Cap. 559) for rectification of error or omission in respect of the following registered trade mark(s).

Under rule 49(3) and rule 16 of the Trade Marks Rules (Cap. 559 sub. leg.), any person who wishes to oppose the application shall, within the 3-month period beginning on the date of this publication, file a notice of opposition on Form T6. (For example, if the publication date is 4 April 2003, the last day of the 3-month period is 3 July 2003.) The notice of opposition shall include a statement of the grounds of opposition. The opponent shall, at the same time as he files the notice of opposition, send a copy of it to the owner of the registered trade mark in question.
