## ACCEPTANCE FOR REGISTRATION

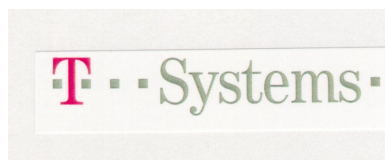

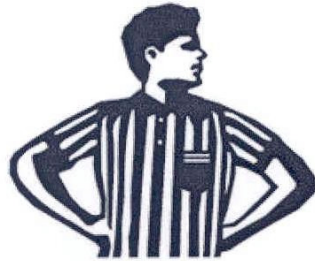

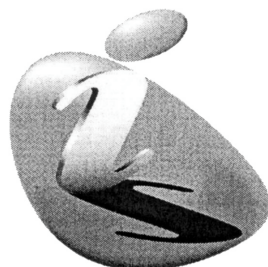
