### ACCEPTANCE FOR REGISTRATION

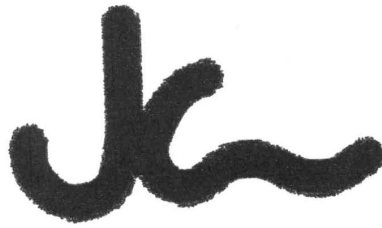
