ACCEPTANCE FOR REGISTRATION

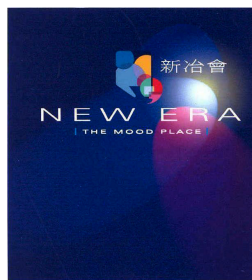

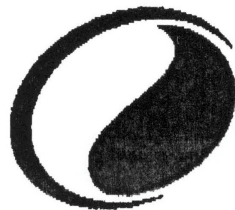

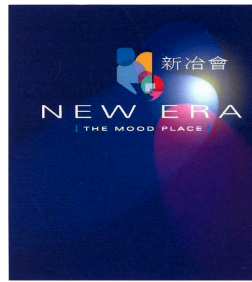
