precious metals and their alloys and goods in precious metals or coated therewith, not included in other classes; jewellery, precious stones; horological and chronometric instruments; clocks and watches; bracelets, charms, cuff links, earrings, necklaces, pendants, tie pins, tie clips, trophies; belt buckles, key chains, necktie fasteners, lapel pins, money clips, napkin rings, shoe ornaments, all being made of precious metals or coated therewith; all included in Class 14.

類別 Class 16

printed matter, photographs, stationery, artists' materials, paint brushes, typewriters, office requisites (except furniture), instructional and teaching material (except apparatus), binders, bookends, bookmarkers, boxes for pens, calendars, writing tablets, cards, pads, pens, pencils, folders, paperweights, pen and pencil, holders, photograph stands, rulers, school supplies (stationery), gift wrap, erasers, markers, crayons, chalk, requisites and materials for artists and craftsmen (other than paints, colours or vanish), desk sets being stationery, desk organizers, bumper stickers; all included in Class 16.

類別 Class 18

leather and imitations of leather, and goods made of these materials and not included in other classes; animal skins, hides; trunks and travelling bags; umbrellas, parasols and walking sticks; whips, harness and saddlery; travel bags, luggage, school bags, back packs, beach bags, duffel bags, waist packs, and umbrellas; all included in Class 18.

類別 Class 21

household or kitchen utensils and containers (not of precious metal or coated therewith); combs and sponges; brushes (except paint brushes); brush-making materials; articles for cleaning purposes; steelwool; unworked or semi-worked glass (except glass used in building); glassware, porcelain and earthenware not included in other classes; mugs and plastic drinking bottles, and piggy banks; all included in Class 21.

類別 Class 25

clothing, headgear; tee-shirts, shirts, tank tops, beachwear, loungewear, boxer shorts, leather jackets, sweaters, sweatshirts, sweat suits, coveralls, jackets, pants, shorts, ties, bandannas, headwear, footwear, bow ties, cardigans, gloves, gym suits, hats, jackets, jogging suits, neckties, polo shirts, scarves, infant's rompers, smocks, socks and visors (clothing); all included in Class 25.

類別 Class 28

games and playthings; gymnastic and sporting articles not included in other classes; decorations for Christmas trees; toys, stuffed toys, plush toys, puppets, dolls, small bean-filled bags used for games and play, board games, video games (other than coin-operated or those adapted for use with television receivers only), toy vehicles, and Christmas tree ornamentation; all included in Class 28.
