The 3 diamentional trademark presenting a hexahedron bottle with a square-like base and rhombus side walls, where longer sides of rhombuses are about 5 times bigger than the side of the base.

External edges of the bottle are shifted by approximately one third of the width of the bottle base in relation to the corners of the base, as the result of which the upper surface of the bottle is shifted by approximately 30° in relation to the base. The bottle has a cylindrical neck placed centrally by the upper surface and its height corresponds to the length of the side of the base. A ring-shaped protrusion is placed on the perimeter of the lower part of a the neck whereas a convex thread is placed in the lower part of the neck.

The bottle has a nut which is a smaller version of the general shape of the bottle. Its upper surface resembles a quadrangle with slightly rounded edges, where a side edge is shorter by approximately one fifth of a side edge of the bottle base whereas the height of the nut is higher by approximately one fifth of the side edge. Furthermore, the upper surface of the nut pictures an engraved symbol of three ears of rye whereas the lower part of the internal surface of the nut contains triple rectangular protrusions.
