### ACCEPTANCE FOR REGISTRATION (FULL VERSION)

The Registrar of Trade Marks has accepted the following trade marks for registration under section 42 of the Trade Marks Ordinance (Cap. 559). The notice of opposition shall include a statement of the grounds of opposition and the matters referred to in rule 16(2). The opponent shall, at the same time as he files the notice of opposition, send a copy of it to the applicant of the application in question.

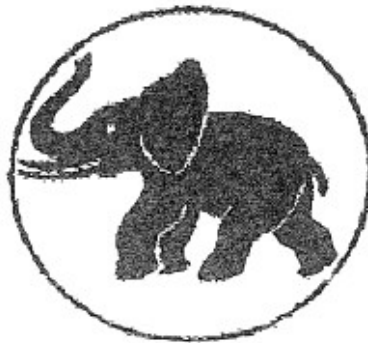
