central nervous system monitors; gastrointestinal tonometers; gradient coils; namely, magnetic gradient coils used in magnetic resonance imaging; medical diagnostic devices, namely, bone densitometers; fetal monitoring apparatus, namely, fetal pulse and vital signs monitors; patient monitoring apparatus, namely, heart and vital signs monitors medical imaging systems, namely, ultrasounds, medical diagnostic imaging machines, imaging devices for screening and diagnostic applications for use in planning intervention and surgery, and parts thereof and attachments thereto; medical diagnostic apparatus for displaying diagnostic images; namely, spot film apparatus, x-ray image intensifiers, x-ray fluoroscopes, mobile x-ray units, radiographic film viewers, computerized tomography scanners, nuclear resonance scanners, ultrasound scanners, magnetic resonance scanners, positron emission tomography (pet) scanners; and parts thereof and attachments thereto including tables and pads.


