The mark is a movement mark consisting of a representation of 50 images in the sequence of movement from Frames 1 to 50 that lasts 10 seconds in total. The starting point is an orange triangle that multiplies to show an increasing number of orange and grey triangles and triangular arrow devices which start to overlap (Frames 1 through to 15); the triangles/arrow devices then appear to gradually turn into a group of runners viewed from the side (Frames 16 to 18), then from both the front and from the side (Frames 19 to 37), then the runners appear to gradually become orange and grey triangles and triangular arrow devices (Frames 38 to 47) and the number of triangles/arrow devices gradually decreases until finally there is a single orange triangle (Frame 48). A FWD logo then appears, leaving the final orange triangle from Frame 48 in the center of the letter D in the logo (Frame 49). 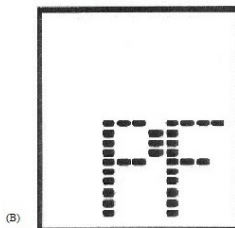
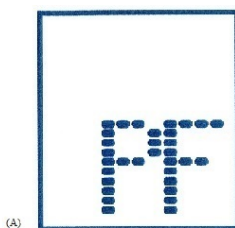
