The notice of opposition shall include a statement of the grounds of opposition, which statement shall, in particular, explain how the opponent would be affected by the amendments if they were made and why in the opponent's opinion the amendments would be contrary to section 58(5) of the Trade Marks Ordinance (Cap. 559).

It should be noted that under rule 95 of the Trade Marks Rules, extension of time cannot be allowed for filing the notice of opposition.
