類別 Class 17

rubber, gutta-percha, gum, asbestos, mica and goods made from these materials and not included in other classes; rubber, gutta-percha, gum, asbestos, mica and goods made from these materials and not included in other classes having anti-slip properties; anti-slip tapes; self-adhesive anti-slip tapes.

類別 Class 19

anti-slip coatings for floors, paths, roads, decks, ramps, stairs; anti-slip panels, boards, blocks, tiles and tile floorings for building construction; anti-slip stairs, stair-treads, and stair tread inserts and anti-slip tread inserts in the form of self-adhesive tapes.
