根據《商標規則》第 95 條，提交異議通知的限期不得延展。

REQUESTS FOR AMENDMENT OF SPECIFICATION OF GOODS OR SERVICES AFTER PARTICULARS OF THE APPLICATIONS HAVE BEEN PUBLISHED

The Registrar of Trade Marks has received the following requests for amendment of applications under section 46 of the Trade Marks Ordinance (Cap. 559).

Under rule 26 of the Trade Marks Rules (Cap. 559 sub. leg.), any person claiming to be affected by the proposed amendment may, within 3 months after the date of this publication, file a notice of objection on Form T6. (For example, if the publication date is 4 April 2003, the last day of the 3-month period is 4 July 2003.) The notice of objection shall include a

statement of the grounds of objection, which statement shall, in particular, explain how the objector would be affected by the amendment and why in the objector's opinion the amendment would be contrary to section 46 of the Trade Marks Ordinance. The objector shall, at the same time as he files the notice of objection, send a copy of it to the applicant of the application in question.

It should be noted that under rule 95 of the Trade Marks Rules, extension of time cannot be allowed for filing the notice of objection.
