(For example, if the publication date is 4 April 2003, the last day of the 3-month period is 3 July 2003.) The notice of opposition shall include a statement of the grounds of opposition. The opponent shall, at the same time as he files the notice of opposition, send a copy of it to the owner of the registered trade mark in question.
