### ACCEPTANCE FOR REGISTRATION (FULL VERSION)

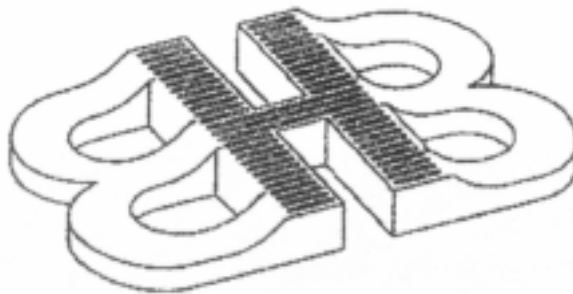

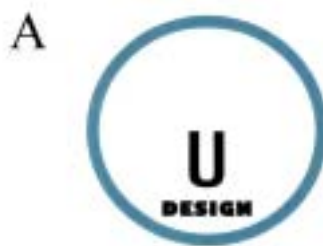
