### 接納註冊 (全文本)

### ACCEPTANCE FOR REGISTRATION (FULL VERSION)

The notice of opposition shall include a statement of the grounds of opposition and the matters referred to in rule 16(2). The opponent shall, at the same time as he files the notice of opposition, send a copy of it to the applicant of the application in question.

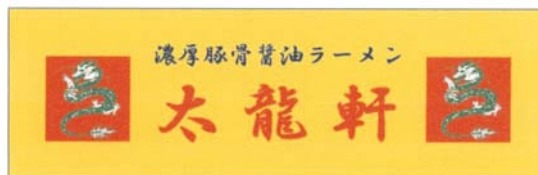

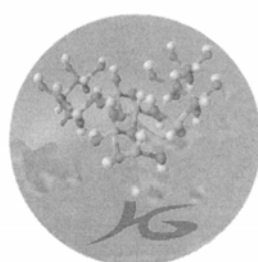
