### **ACCEPTANCE FOR REGISTRATION**

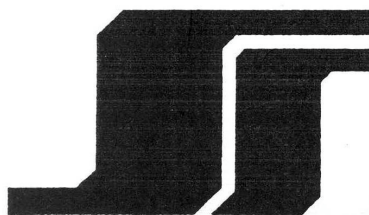

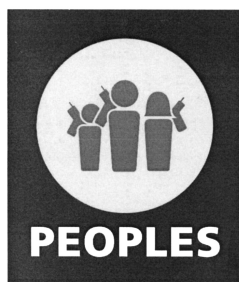
