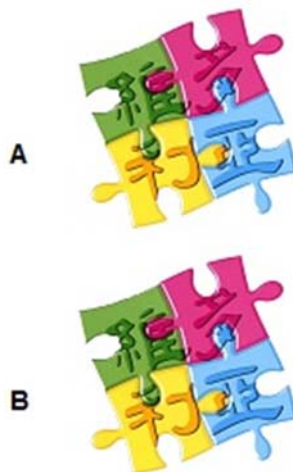

transactions, processing of financial transactions and transmission of photographic images, text, graphics and data; providing search engines for electronic commerce transactions; providing search engines for obtaining data on a global computer network; providing temporary use of non-downloadable computer software that allows users to send, receive, transfer, store, and safeguard digital currency; providing temporary use of online, non-downloadable computer software that allows subscribers to utilize voice over internet protocol (VOIP) communication services; scientific and technological services and research and design relating thereto; smartphone software design; software and platform as a service (SAAS) and (PAAS) featuring computer software platforms for the trading of goods and services; software creation; software design and development; support and consultation services for developing computer systems, databases and applications; technical consulting in the field of computers, mobile phones and consumer electronics; technical support services, namely, troubleshooting computer hardware, computer peripheral, computer software, mobile phone hardware, application software and consumer electronic devices; unlocking of mobile phones; updating of smartphone software.
