### 接納註冊 (全文本)

### ACCEPTANCE FOR REGISTRATION (FULL VERSION)

The opponent shall, at the same time as he files the notice of opposition, send a copy of it to the applicant of the application in question.

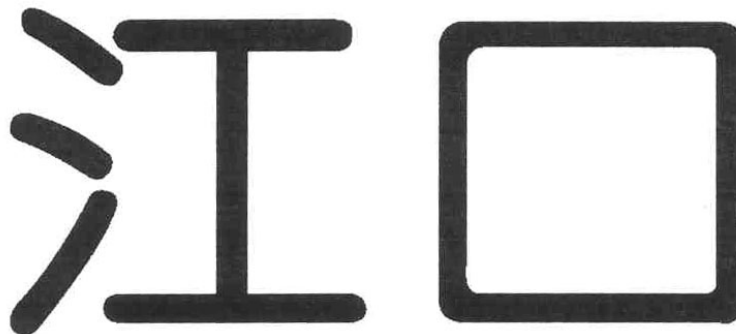

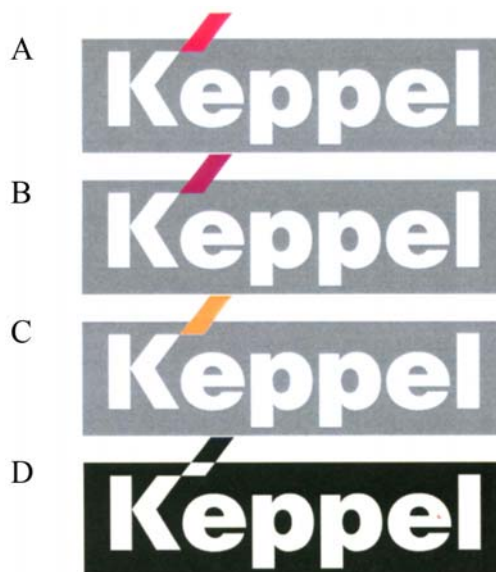
