根據《商標條例》（第559章）第57(6)條和 《商標規則》（第559章附屬法例）第66條 擬改正商標註冊紀錄冊中的錯誤的通知

商標註冊處處長注意到下開所列已記入商標註冊紀錄冊（「紀錄冊」）內的一些註冊商標和商標註冊申請的提交日期、註冊日期、註冊屆滿日期或聲稱具有優先權的資料出現錯誤。

商標註冊處處長已即時根據《商標條例》（第559章）第57(6)條和《商標規則》（第559章附屬法例）第66條採取行動以改正有關錯誤。處長現正向商標註冊擁有人、商標註冊申請人及處長覺得受牽涉的人（如註冊特許持有人）送交擬作改正的通知。

如你因擬就下開所列註冊商標和商標註冊申請作出的改正受牽涉，而你又不曾收到處長根據《商標規則》第66條發出的通知，你可在此通知的日期後的3個月內就擬作出的改正提出書面異議，述明異議的理由。如在該限期內沒有書面異議提交，則處長可着手在紀錄冊中作出擬作出的改正。

Notice of proposed correction of errors in the register of trade marks under section 57(6) of the Trade Marks Ordinance (Cap. 559) and rule 66 of the Trade Marks Rules (Cap. 559 sub. leg.)

It has come to the attention of the Registrar of Trade Marks that there are errors (listed below) in the register of trade marks in respect of the filing dates, dates of registration, expiry dates or priority claims of certain applications and registrations.











The Registrar is taking immediate action to correct the errors in the register under section 57(6) of the Trade Marks Ordinance (Cap. 559) and rule 66 of the Trade Marks Rules (Cap. 559 sub. leg.). The Registrar is sending notices to the registered owners / applicants concerned as well as any other persons who appear to him to be concerned (e.g. registered licensees) informing them of the errors and the correction proposed to be made.

If you are concerned with the correction proposed to be made to any of the applications and registrations listed and you have not received a notice from the Registrar issued pursuant to rule 66 of the Trade Marks Rules, you may, within 3 months after the date of this notice, make written objections to the proposed correction stating the grounds of your objections. If no objections are filed within that period, the Registrar may proceed to make the proposed correction to the register.



