## 改動註冊商標

商標註冊處處長擬根據《商標條例》 (第 559 章)第 55 條,容許以下註冊商標作出下列 改動。

根據《商標規則》(第 559 章附屬法例)第 55 (1)條,任何聲稱受擬作出的改動影響的人,可在本公告公布的日期後的三個月內,採用表格第 T6 號提交異議通知。(例如,若果公布日期爲 2003 年 4 月 4 日,則該三個月的最後一日爲 2003 年 7 月 4 日。)異議通知須載有提出異議的理由的陳述,該陳述尤須解釋如作出改動,異議人會如何受該項改動影響,以及異議人為何認為該項改動會違反《商標條例》第 55 條。異議人須在提交異議通知的同時,將該通知的副本送交有關註冊商標的擁有人。

根據《商標規則》第95條,提交異議通知的時限不得延展。

## ALTERATION OF REGISTERED TRADE MARK (S)

The Registrar of Trade Marks proposes to allow the following alteration of registered trade mark (s) under section 55 of the Trade Marks Ordinance (Cap. 559).

Under rule 55(1) of the Trade Marks Rules (Cap. 559 sub. leg.), any person claiming to be affected by the proposed alteration may, within 3 months after the date of this publication, file a notice of objection on Form T6. (For example, if the publication date is 4 April 2003, the last day of the 3-month period is 4 July 2003.) The notice of objection shall include a statement of the grounds of objection, which statement shall, in particular, explain how the objector would be affected by the alteration if it were made and why in the objector's opinion the alteration would be contrary to section 55 of the Trade Marks Ordinance. The objector shall, at the same time as he files the notice of objection, send a copy of it to the owner of the registered trade mark in question.

It should be noted that under rule 95 of the Trade Marks Rules, extension of time cannot be allowed for filing the notice of objection.
