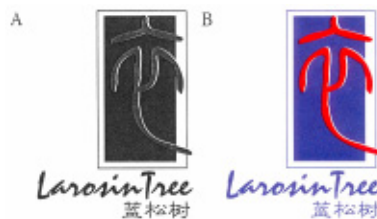

The opponent shall, at the same time as he files the notice of opposition, send a copy of it to the owner of the registered trade mark in question.
