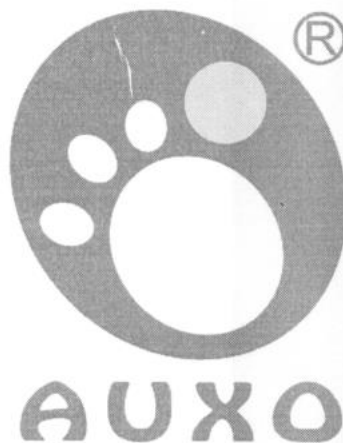

Retail and on-line retail store services in respect of cosmetics, hairdressing, cleaning preparations, nutrition replacement, health supplements, beverages and foods, therapeutic and physiotherapy products; direct mail advertising; marketing and promotional services; business management and organization consultancy; dissemination of advertising matter via mail order publications; commercial information agencies; outsourcing services [business assistance]; procurement services for others [purchasing goods and services for other businesses]; sales promotion [for others]; commercial information and advice for consumers [consumer advice shop]; import-export agencies; auctioneering; systemization of information into computer databases; organization of exhibitions for commercial or advertising purposes.
